Pursuant to the provisions of Article 17 of Regulation (EU) No. 596/2014 on market abuse and Article 227 of Law 6/2023 of 17 March on Securities Markets and Investment Services, and concordant provisions, as well as Circular 3/2020 of the BME Growth segment of BME MTF Equity, we hereby bring to your attention the following information regarding SECUOYA, GRUPO DE COMUNICACIÓN, S.A. (the "Company" or "Secuoya"):

Today, the Council of Ministers of the Government of Spain has granted the required authorization for the Spanish Society for Technological Transformation (SETT) to acquire a stake of up to 49% in an investment vehicle named AURORA MEDIA INVERSIONES, S.I.C.C., S.A. (the "SICC"), a company incorporated pursuant to the provisions of Law 22/2014 of 12 November, which will also be participated in by Secuoya and Société Générale, Spanish Branch.

Secuoya, as the industrial partner, will contribute its strategic vision and execution capabilities, as well as identify opportunities and submit them for the corresponding evaluation, with particular focus on projects aligned with the objectives of the Spain Audiovisual Hub Fund, promoted by the Government of Spain within the framework of the Recovery, Transformation and Resilience Plan.

The SICC will focus on identifying investment opportunities related to the development, promotion, acquisition, production, distribution, exploitation and exhibition of audiovisual content, as well as the full range of services and technologies associated with the sector, and is expected to have a duration of 15 years and an investment period of 10 years.

The SICC is currently undergoing the registration process with the CNMV. Once registered, the corresponding prospectus containing the details of the vehicle will be filed and published with the CNMV. The Company will keep the Market duly informed of the progress of this process.
